## BRAINSTORMING II Report

The Executive Committee and interested members from across the state met at the Hampton Inn in Clinton, SC in October to pool their ideas about three specific tasks.: increasing the number of organized counties, forming Action Committees and developing "A Contract with South Carolina".

Increasing membership is the key to having more organized counties is was concluded and a significant amount of time was spent on developing creative ideas to accomplish this task. Contact with pro-libertarian Letter to Editor writers, re-establish contact with former organized counties and advertising and press releases in local/county papers. The Exec Comm will be calling on all county chairs to contribute to this effort.

Several Action Committees were established making the committees and Chairmen as follows: Membership, Victor Kocher; Newsletter, Stewart Flood; Media, Barry Gray; Legislative, n/a; Political, State Chair, Michael Carmany; College Outreach, Truman Horner.

The idea for “A Contract with South Carolina” was debated. Some felt that we need to have a guideline for candidates so that we run a unified message. Others thought that the SC Party Platform would suffice. The conclusion was that another Brainstorming Session on candidate recruitment and training should be held in March.

## Why I Am a Libertarian

I grew up in a family that is best described as left leaning/political independent. No one in my family was involved in party politics, but most did have an interest in individual candidates or issues. This lack of “indoctrination” left me with a blank slate to form my own political beliefs, but it also gave me no starting point going into adulthood.

In 1984 I wanted to be an informed voter, and studied parties from the left and right, the Libertarian Party was one of these, however, due to age and inexperience none of them spoke to me in a meaningful way. This led to roughly twenty years of supporting, volunteering for, and voting for a variety of candidates without considering political affiliation. I was among the political homeless. The one positive out of this was that I discovered I was a believer in the multi-party system.

During these years I generally supported the positions of the political left. But there were three issues in particular that I have always held dear. I have always been a supporter of Second Amendment rights. I have always supported small business and entrepreneurship. But most importantly I have always had a belief in Individual Freedom.

In 2004 I began an affiliation with the Green Party. The Four Pillars and Ten Key Values seemed to offer a foundation that a movement could be built on. In three to four years I became very active including serving on the state steering committee and running for office in 2007 and 2008. Ironically it was as a candidate for York County Council that I began to lose confidence in the national Green Party’s commitment to their Ten Key Values. Without going into specifics, they were steamrolling to the left, and I began to distance myself and my campaign from the “party line“.

During the campaign, I had to deal with two life threatening health issues. About a month into the recovery ordeal a healthcare professional suggested that I seek Social Security Disability. This attitude bothered me since I had planned to return to work (and did) as soon as I was able. With individual freedom comes individual responsibility, and at some point I may need charity, but charity is the absolute last resort. I refuse to promote an agenda that would cause even one person to adopt the attitude that going on disability was preferable to working through a hardship. I began to question my political stances. Do they support people to take the easy way out, allowing themselves to become a ward of the state on the back of the taxpayer? Earlier in the year I had watched part of the 2008 Libertarian National Convention on C-Span and found that I agreed with much of their message. So, during this time of self-evaluation I decided to devote time to further study of the Libertarian Party platform.

From Green to Libertarian? It’s not as far-fetched as one may think. Many, if not most Greens would accept or support as much as half of the LP platform as it stands. As for me, when I studied the platform I found I was already in full agreement with most of it, and when looked upon objectively, I felt I could support all of it. The process of my political “switch” had already been put in motion, but I admit that my health crisis re-energized a belief in personal liberty and responsibility.

In the final two months of the 2008 campaign season, I no longer believed in the liberal agenda of the GP. I could no longer in good conscience promote a philosophy which rewards sloth and penalizes initiative. However, because I had made a commitment to the GP, and I honor my commitments, I stuck with them through Election Day and never came out in direct opposition to them. Shortly after the election I resigned from the Green Party and “officially” began what I hope will be a long and productive affiliation with the Libertarian Party.

### Libertarian as a Classic Liberal

OK, we now have a Democrat in the White House...or maybe a better description would be a Progressive. We used to have either Democrats, who supported all kinds of social programs, or Republicans, who favored small government. . Beginning around the turn of the 20<sup>th</sup> century, other movements arose such as: “social” democrats, “progressives”, “new dealers”, “great societies”, “compassionate conservatives”, “neo-cons” and who knows how many more. A strong socialist movement also

arose which favored partial or complete takeover by the government of the means of production.

**All these various philosophies spilled over into both Democratic and Republican parties until it seems that present day politicians of both parties are trying to capture the voter where he really is...in the center.** The mixture of these movements created the current “welfare” state where government provides huge welfare programs to individuals, States and businesses and where government does not necessarily “own” many businesses, but regulates nearly every aspect of their operation.

So, when a politician runs as a Democrat or as a Republican we don’t really know what he stands for, what his policies may be or how he will govern. It used to be pretty clear – now, we can’t be so sure.

With the economic ‘crisis’ which we now have before us and the disastrous neo-cons behind us, we are in dire need of establishing a common sense method of handling the problems of society, both social and economic. Of course, we believe that the libertarian political philosophy fills the bill. In the past the “classic” liberal beliefs have largely been the engine that pulled society into fiscal prosperity and a higher standard of living. Classic liberalism stresses individual freedom and limited government and that includes property rights, protection of civil liberties, constitutional limitation of government, free markets. “Laissez-faire economics”, the belief that an unconstrained market will balance itself in the long run and will lead to an improved living standard is a main-stay of classic liberalism.

Libertarians can be subdivided into two groups: minarchist and anarchist. Both are examples of a certain kind of “classic” liberal. The minarchist libertarian maintains that government should impartially but minimally work for the common good whereas the anarchical libertarian wants the public good to be accomplished via a network of private contracts without government involvement.. As in any political or philosophical group there are varying degrees of acceptance of its tenets. The Libertarian Party, since its inception, has firmly asserted that a bloated government slowly but surely takes away the freedom of the individual.

The welfare state is a good example of a government program that has completely eviscerated the freedoms of a large group of citizens. The lives of welfare recipients are largely run by the government and freedom of choice and personal responsibility for solving their own problems is rarely considered. And consider the federal intrusion into education. Whereas, before the Department of Education existed, local school boards were beholden to the local community, they are now committed, first, to federal “guidelines” that mandate who, how, what, where and when your child will be educated. You and your school board have lost freedom of choice in the matter.

And now we are about to enter an era of corporate welfare where government gives money to business and demands, in return, almost complete control of the operations. (This used to be called “fascism”.) Oh, it might seem like government control of businesses doesn’t affect you but when businesses lose their freedom to choose or even to fail, you lose your freedom of choice also. Just like when government increases business taxes guess who pays it? You get it, you do in increased cost of goods and services.

The beginnings of the economic crisis we are living through, in part, can be laid at the doorstep of the portal we stepped through when the decision was made that the federal

government should use legislative power to increase home ownership. When Congress mandated through regulation and guarantees that everyone should be a homeowner, it opened the door for all kinds of fancy footwork when it came to underwriting this process. The trust that was previously put in the mortgage lender to make sound business judgments as to the worthiness of an applicant was skewed by the government mandate to “put them in a home”. This, of course, was followed by the cunning of the ‘high flyers’, both Fannie and Freddie and the ones on Wall Street. When the government guarantees that the business won’t fail, the business is free to take any risk.

The current tactic of the government “investing“ in the private sector seems to have taken the idea of social engineering and applied it to economic engineering. This is not the first time it’s been done but it has taken it to a higher level. If you want a business model for shutting down an economy just study governments of all ilks going back as far as the Ming Dynasty of China. Periods of rising productivity were choked off by institutional barriers - a plethora of rules and regulations and taxation.

So, classic liberalism or libertarianism thinking is what is needed to get us out of this mess. It has proven itself over the test of time to qualify for that position in “center court” where the vast majority of the citizens are firmly planted. We don’t expect the President to do an about face in his politics but we hope that in his study of history and the Constitution he has come across the historic evidence that big, bloated government is bad governance.
